I take full responsibility in respect of the conditions as set down and also understand that a spot check may take place on my motorcycle before, during or after the event for safety and other reasons.
2. I shall abide by any decision directed at me by the Steward of the Meeting. And understand that any competitor making a false declaration may be disqualified from the event.
3. I have read the Supplementary Regulations for this Competition and agree to be bound by them and the Manual of Motorcycle Sport, the MNZ Constitution, and the MNZ Code of Conduct.
4. I am aware that the sport of Motorcycle Competition might a) cause me injury; serious or otherwise, b) damage my property.
5. I wish to take part in the 2019 Queen’s Birthday MX Event despite the above risks.
6. Neither I, nor anyone associated or connected with me will make any claim against you or your officers, employees or agents in respect of: a) any injury suffered by me; or b) any damage to any of my property regardless of how the injury or damage occurs.

Licences:	This is not a championship event, therefore all licensed riders can race. MNZ Licences are required; One Event Licences are available at sign on for \$30.00. Please note this on your entry form and pay the fee along with your entry fee via cheque or direct credit.
Classes:	Minimum requirement to run a class is 5 riders (at organiser's discretion) Main track classes will be restricted to 40 starters (qualifying will take place if more entries are received) Classes may be split into other age groupings or combined, dependant on entries <i>Please note that class eligibility is determined by your age on the day (2nd June 2019)</i>
Entry Fees:	Entries postmarked after the closing date "may" be accepted at the organisers discretion. A late entry fee (an additional \$20.00) will apply. Entry fee includes transponder hire and there will be <u>NO</u> reduction in price if you provide your own.
Acceptance:	All entries to be treated as accepted
Sign on:	07:30-08:30 Sharp
Riders Briefing:	08:45 - ALL riders must attend
Practice/Qualifying:	Start time will be 9am (1 look lap, 3 laps practice/qualifying)
Race Format:	Initial practice/qualifying and 3 races per class of not more than 8 minutes plus one lap per race for Mini Track, 8 minutes plus one lap for 65cc bikes, 12 minutes plus one lap for Junior 85cc riders 125/250cc riders, Vets and MX3 and 14 minutes plus one lap for Seniors. Racing is expected to be completed at approximately 4pm
Gate Position:	Gate selection for riders will be by qualifying position
Lap Scoring:	Lap scoring will be Electronic Transponder System
Prize Giving:	As soon as possible on completion of racing (no earlier than 30 minutes after the final race results are posted); Trophies 1 st – 3 rd . No Participation medals will be awarded.
Race Numbers:	Correct racing numbers as issued by MNZ as on your MNZ Licence are to be worn on the back of body armour or jersey and on bikes as per rule 10.2b. Correct number board colours to be used as per rule 10.3b. In the event of duplication in bike numbers, riders/parents/guardians will be notified before the event where a number change is required (time permitting)
Force Majeure:	For reasons of Force Majeure, should the meeting or part of the meeting be cancelled, entry fee refunds will only be made at the sole discretion of the organisers
Refunds:	Please note the MNZ rule 5-6-2 will be applied

NO Dogs	Dogs are not permitted at this venue and you will be asked to leave
